The Canadian Mental Health Association – Halton Region Branch (CMHA-HRB) is seeking a full time permanent Case Manager, as part of our Home for Good from the Halton Region. The position is a 37.5 hours per week role based in our Oakville, Ontario office primarily serving Halton Region. The position resides within an integrated team of individuals who work closely together to provide meaningful programs to people affected by mental illness and addictions and to promote mental health in the community.

## The Successful Candidate Will:

- Provide individual 1:1 support coordination to clients with significant mental health issues living semiindependently in temporary shelter in the greater Halton community
- Focus on strategies to continue to stabilize clients with mental health concerns into the community and practical interventions for enhanced success in independent housing
- Make referrals on behalf of clients to a wide variety of community programs and services
- Support individuals within the mental health system by empowering them, identifying goals and strengths and successfully implementing formal and informal supports
- Promote the development of enhanced capacities and a holistic approach to recovery through enhanced functioning, community involvement and healthier relationships

## **Responsibilities:**

- Screen and intake eligible individuals engaged in the Housing First program by the Halton Region for CMHA case management support
- In collaboration with each individual being sheltered, acquire sufficient food, clothing, personal needs and supplies needed to bridge them to OW or similar financial supports.
- In partnership with the Housing First program providers, create a rehousing plan with each individual that adequately addresses their needs with the goal of achieving resolution of their housing crisis within 60 days
- Provide individual support to individuals with mental health and/ or addictions issues that negatively impact their ability to find and maintain stable housing
- Support individuals by empowering them, identifying goals and strengths and successfully implementing formal and informal supports
- Promote the development of enhanced capacities and a holistic approach to recovery through enhanced functioning, community involvement and healthier relationships





- Identify gaps that contribute to housing instability and address them through referral and advocacy to a wide variety of community programs, supportive counselling, group work, personal coaching and life skills training.
- Focus on strategies to reintegrate clients with mental health concerns into the community
- Provide aftercare support to individuals in CMHA case management support who are graduating from the Housing First Program and proactively reengage with them if needed to prevent further episodes of homelessness
- Commit to supporting health, safety and wellness according to relevant legislation and agency policies and procedures
- Responsible for all aspects of case management and maintenance of client records
- Perform community outreach and possess a knowledge base of community resources and services
- Work collaboratively with community partners in a multidisciplinary approach
- Liaise and collaborate with Landlords/ Superintendents to ensure units are in good repair and Lease
   Hold Agreements remain in good standing
- Other duties as assigned
- The position occasionally entails the transportation of clients. A valid Ontario Class "G" driver's license and a vehicle with 2 million dollar insurance coverage is required.
